Local Bounty Coshocton is a physical market space where sellers rent display space annually for their products. Vendors pay a vending fee for space at the market and a consignment percentage based on sales. These are outlined in our Producer Guidelines.

To hold fast to our goal of promoting sustainability, we will not accept anyone as producer members who:

- Resells or broker products bought elsewhere.
- Raises animals in large industrial concentrated animal feeding operations (CAFO) as defined by the Ohio Revised Code

Local Bounty Coshocton reserves the right to release any vendor from the business who breaks our producer guidelines (without reimbursing a vendor fee).

Due to the possibility of space constraints in the market we have established guidelines for prioritizing products based on size of operation, location, and agricultural practices. We also reserve the right to deny a vendor whose product doesn't align with our goals and/or meet our level of quality.
